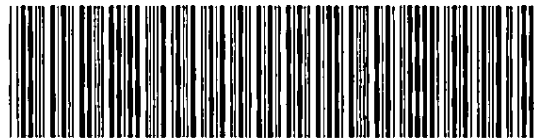

### Operating Agreement




