THESE ARTICLES OF MERGER (the "Articles") are made and entered into on this 1st day of September, 2022, by and between PUSHBACK INCORPORATED, LLC, a Texas limited liability company (the "Merging LLC"), and FLYIN' CAYUSE VENTURES, LLC, a Florida limited liability company (the "Surviving LLC"), in accordance with Sections 605.1021-605.1026 of the Florida Revised Limited Liability Company Act:

NINTH: The terms and conditions of the transaction set forth in the Plan of Merger which is incorporated into the Articles of Merger were advised, authorized, and approved by unanimous consent of the Members and Managers of both the Merging LLC and the Surviving LLC.
