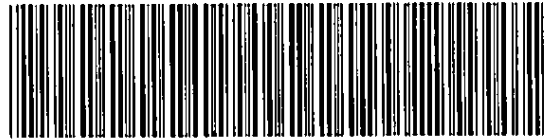

No need to pay money in keeping business active if it isn't able to produce an income as intended.

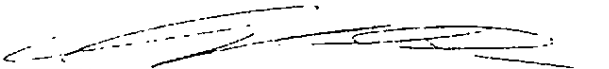
