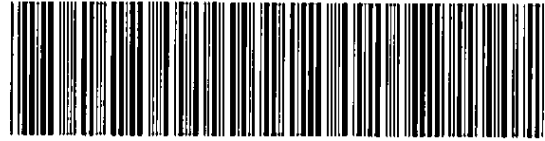

ARTICLES OF ORGANIZATION

3SA LLC
