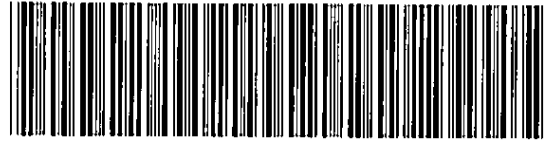

The name of the Limited Liability Company is "**TT of Industrial, LLC**" (the "**Company**").


