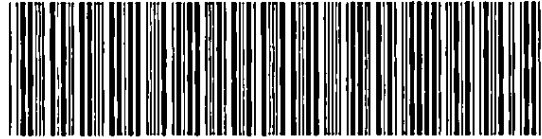



**ARTICLES OF ORGANIZATION

ARTICLE X - AMENDMENT

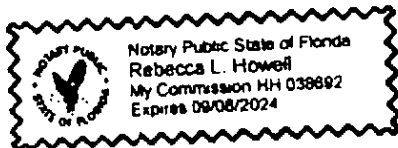

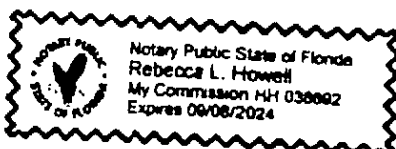
