OF

**ARTICLE I
NAME & ADDRESS**

INITIAL REGISTERED OFFICE AND AGENT

The power to adopt, alter, amend or repeal an Operating Agreement governing the operation of the Company shall be vested in its members.

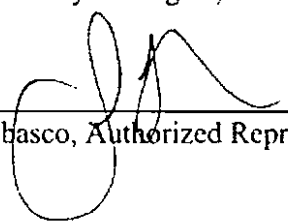
ARTICLE VI

IN WITNESS WHEREOF, the undersigned authorized representative of the initial members has executed these Articles of Organization this 31st day of August, 2022.

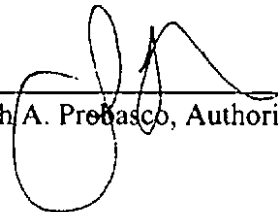

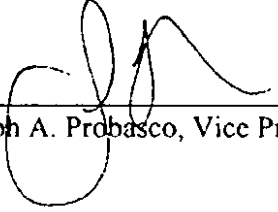
