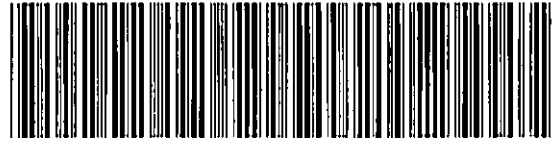

1. The name of the "Other Business Entity" immediately prior to the filing of the Articles of Conversion is **New Bless LLC**.

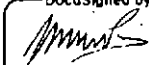
2. The "Other Business Entity" is a limited liability company first organized, formed or incorporated under the laws of the State of Michigan on May 6, 2020.

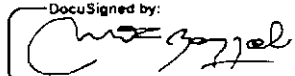

**ARTICLES OF ORGANIZATION
OF
NEW BLESS LLC**

The undersigned, being the manager, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is New Bless LLC (the "Company").

**ARTICLE II
ADDRESS**

**ARTICLE III
REGISTERED AGENT AND OFFICE**

PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

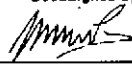
ARTICLE VII
ADDITIONAL MANAGERS

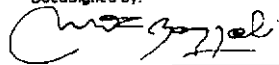
