**ARTICLES OF ORGANIZATION
OF

The undersigned, HORACE STEPHEN SMITH, competent to contract and an authorized representative, hereby presents these Articles of Organization as the Articles of Organization of SMITH FAMILY LAKEHOUSE, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is SMITH FAMILY LAKEHOUSE, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and principal address of the Company is 3520 Connell Drive, Pensacola, Florida 32503. The Company's mailing address and principal office may hereafter be at such other place or places as its member from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

ARTICLE V - REGISTERED OFFICE AND AGENT


The initial registered agent of the Company is Horace Stephen Smith, and the initial address for that registered agent is 3520 Connell Drive, Pensacola, Florida 32503.


