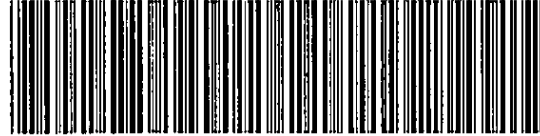

**AMENDED & RESTATED ARTICLES OF ORGANIZATION
OF
1209 BAYSHORE, LLC**

SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

The undersigned Authorized Representative desires to amend and restate the Articles of Organization for the limited liability company, 1209 Bayshore, LLC under the Laws of the State of Florida by delivering these Amended Articles of Organization in duplicate to the Department of State of the State of Florida, in accordance with the Florida Revised Limited Liability Company Act, Chapter 605 (the *Act*).

SECTION 2 NAME

The name of the limited liability company is 1209 Bayshore, LLC, a Florida limited liability company (*LLC*).

SECTION 3 EFFECTIVE DATE AND DURATION

The effective date of this Amendment & Restatement to these Articles shall be February 16, 2023. The period of duration of the LLC shall be perpetual.

SECTION 4 LLC'S PURPOSE

The LLC's purpose is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and all activities necessary or incidental to that purpose. The LLC has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.

SECTION 5 LLC'S PRINCIPAL OFFICE AND LOCATION OF RECORDS

The street address and mailing address of the principal office in the United States where the LLC maintains its records is 1209 Bayshore Blvd, Tampa, Florida 33606.

SECTION 6 REGISTERED AGENT AND REGISTERED OFFICE

The LLC's Registered Agent is Tyler Blake and the LLC's initial registered office is located at 9501 Princess Palm Ave, Tampa, FL 33619. The LLC may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with the Act.

SECTION 7 AUTHORIZED REPRESENTATIVE'S NAME AND ADDRESS

The Authorized Representative's name is Tyler Blake, a natural person whose address is 1209 Bayshore Blvd, Tampa, Florida 33606.

SECTION 8 ADDITIONAL MEMBERS

The LLC has the right to admit additional Members to the LLC under the terms and conditions of the LLC's Operating Agreement.

SECTION 9 MANAGEMENT THROUGH MANAGING MEMBER

All powers of the LLC shall be exercised by or under the authority of the managing member and, except as otherwise provided in the operating agreement of the LLC, if any ("Operating Agreement"), the business and affairs of the LLC shall be managed by or under the direction of the managing member(s). For clarity, the sole member who shall serve as the Managing Member of the LLC shall be Midwest Alarm Company a/k/a Midwest Alarm Company, Inc. c/o Tyler Blake ("Member" or "Managing Member") whose mailing address is 1209 Bayshore Blvd, Tampa, FL 33606.

SECTION 10 OPERATING AGREEMENT AND AUTHORITY

To the extent not expressly required by and provided for in the Act, the manner in which the LLC conducts its business and affairs, the duties and authority of its Member, and the rights and obligations of its Member must be set forth in the Operating Agreement adopted by the Member of the LLC. This Operating Agreement may be amended from time to time according to its provisions.

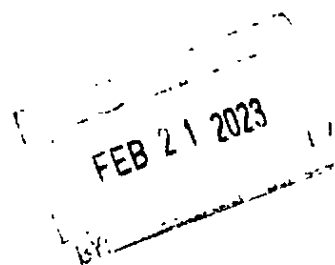
