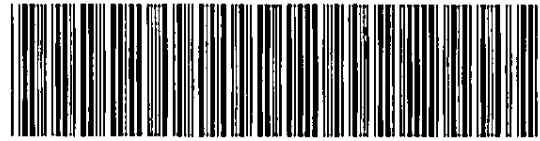

No appraisal rights in favor of the shareholders of **Precision Electric of Lakeland Inc.** arise in connection with this conversion.




