**ARTICLES OF ORGANIZATION
of
DUVAL PAINT HOLDINGS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Duval Paint Holdings, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 2855 St Johns Bluff Road, South, Jacksonville, Florida 32246.

ARTICLE II

PURPOSES AND POWERS

ARTICLE VII**DURATION AND COMMENCEMENT**




