

Pursuant to the provisions of Section 605.0209, F.S., this document is being submitted to correct a previously filed document.

FIRST: The name of the limited liability company is **CDC Investment Properties, LLC** (the "Company").

SECOND: This Statement of Correction corrects the Articles of Conversion and Articles of Organization of the Company filed with the Department of State of Florida on September 13, 2022 and assigned Document number L22000394598.

THIRD: The signature page of the Articles of Conversion was defectively signed because the name of the sole member of the Company, which executed the Articles of Conversion on behalf of the Company, was incorrectly spelled.

FOURTH: The correct name of the sole member of the Company is "**CDC Land Investment Holding, Inc.**"

FIFTH: The preamble of the Articles of Organization incorrectly spelled the name of the member of the Company. Article III of the Articles of Organization incorrectly identified the Company as member-managed and the signature page of the Articles of Organization was defectively signed because the name of the sole member of the Company, which executed the Articles of Organization, was incorrectly spelled.

SIXTH: The preamble of the Articles of Organization is corrected as follows:

Pursuant to Florida Statutes §605.0201, the undersigned sole member, **CDC Land Investment Holding, Inc.**, hereby submits the following Articles of Organization of **CDC Investment Properties, LLC** for the purpose of forming a limited liability company under the laws of the State of Florida.


SEVENTH: Article III of the Articles of Organization is corrected as follows:
