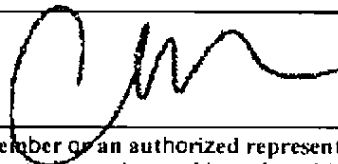

### Instructions - Letter of Consent to use a business name

In some cases having a letter of consent can strengthen the chance of getting a business name approved. This depends on the state and specific circumstances. Generally, consent letters are on company letterhead and include:

- The name and address of the existing company
- The name, title, and signature of the person giving consent on behalf of the company - usually a member for an LLC, an officer for a corporation, or a general partner for an LP
- Language that gives consent to someone specifying their name and their proposed business name (see the end of these instructions for an example)
