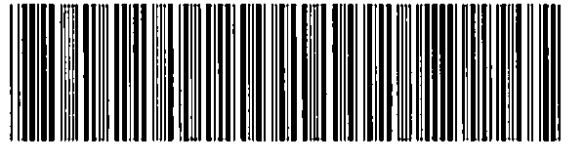



**FIFTH:** The Converted Entity has agreed to pay any members having appraisal rights the amount to which they are entitled under Sections 605.1006 and 605.1061–605.1072, *Florida Statutes*.
