ARTICLES OF ORGANIZATION OF KISSIMMEE PIZZA SERVICES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE J

Name. The name of the limited liability company shall be Kissimmee Pizza Services, LLC ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 5770 W. Irlo Bronson Memorial Highway 144, Kissimmee, FL 34746.

ARTICLE III

<u>Duration</u>. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

ARTICLE IV
