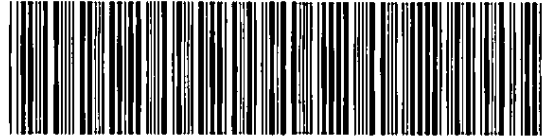

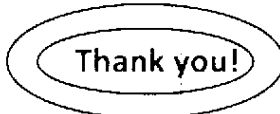

ARTICLE I — Name:

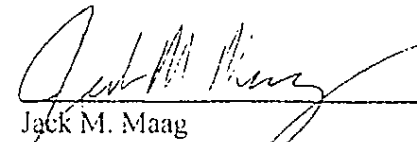
ARTICLE VI — Indemnification
