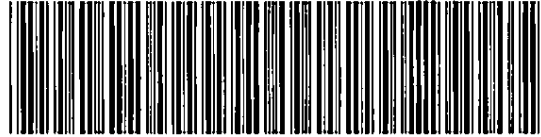

The principal office address and the mailing address of the Company is 30190 U.S. Highway 19N, #1186, Clearwater, FL 33761.


ARTICLE III


