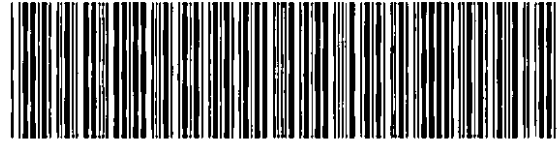

FIFTH: The merger shall become effective as of September 28, 2022.




