ARTICLES OF ORGANIZATION DIRIENZO RIVER ROAD LLC

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended, superseded or replaced (the "<u>Act</u>").

<u>ARTICLE I – NAME</u>

The name of this limited liability company (the "Company") is DIRIENZO RIVER ROAD LLC.

ARTICLE II – ADDRESS
