**ARTICLES OF ORGANIZATION

Locklear, a natural person competent to contract and an authorized representative of 1st City Consulting, LLC, hereby presents these Articles of Organization as the Articles of Organization of 1st City Consulting, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is 1st City Consulting, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and initial principal address of the Company is 525 N. Spring Street, Pensacola, Florida 32501. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS
