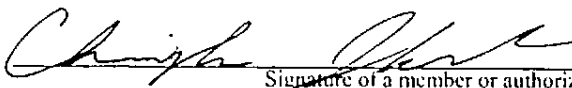

MEMBERSHIP INTEREST PURCHASE AGREEMENT

This **MEMBERSHIP INTEREST PURCHASE AGREEMENT** (this "Agreement") is made by and between Brock Rudzki ("Rudzki") and ABC Electricity LLC ("ABC") as of January 1, 2024 (the "Effective Date"), and is joined by Chris Jackson and Arnel Gabriel as the remaining members of ABC.

WITNESSETH:

WHEREAS, the current issued and outstanding equity ownership in ABC is as follows:

Brock Rudzki	333	33 1/3%
Chris Jackson	333	33 1/3%
Arnel Gabriel	333	33 1/3%

WHEREAS, Rudzki desires to sell to ABC, and ABC desires to purchase from Rudzki, 333 units of his Membership Interest in the LLC, representing 33 1/3% of the issued and outstanding membership interests in the LLC (the "Purchased Interest").

NOW THEREFORE, for the consideration set forth below and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Rudzki hereby sells to ABC, and ABC hereby purchases from Rudzki, the Purchased Interest, on the terms and conditions set forth below.

1. **SALE AND PURCHASE.** Rudzki hereby sells to ABC, and ABC hereby purchases from Rudzki, the Purchased Interest free and clear of any liens, claims, security interests, options, or other encumbrances, for the consideration set forth in Section 2 below.

2. **CONSIDERATION.** The consideration given by ABC to Rudzki for the Purchased Interest is the sum of \$5,000.00, to be paid by ABC to Rudzki within 30 days of the date hereof. Rudzki acknowledges the sufficiency of the consideration.

3. **REPRESENTATIONS AND WARRANTIES.** Rudzki hereby represents and warrants to ABC that: (a) the Purchased Interest represents a 33 1/3% Membership Interest in the LLC; and (b) Rudzki is the lawful owner and has good title to the Purchased Interest, free and clear of any liens, claims, security interests, options, or other encumbrances.

4. **POST-SALE INCUMBENCY ACKNOWLEDGMENT.** ABC, Chris Jackson and Arnel Gabriel confirm and agree that, on and after the Effective Date hereof, the then-current issued and outstanding equity ownership in ABC is as follows:
