ARTICLES OF ORGANIZATION OF
MAC 12ST HOLDINGS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (the "Act") of the State of Florida pursuant to Chapter 605 of the Florida Statutes hereby makes, acknowledges, and files the following Articles of Organization providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

ARTICLE I
NAME

The name of the limited liability company shall be **MAC 12ST HOLDINGS, LLC** (the "Company").

ARTICLE II
MAILING ADDRESS

The mailing address for the Company shall be 8764 SW 124 St, Miami, FL 33176.

ARTICLE III
INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of the Company is 8764 SW 124 St, Miami, FL 33176 and the name of the company's initial Registered Agent for service of process in the State of Florida, at that address is Amado Cabrera.

ARTICLE IV
PURPOSES AND POWERS

**ARTICLE VI
STREET ADDRESS OF PRINCIPAL OFFICE**

The street address of the principal office of the Company shall be located at 8764 SW 124 St, Miami, FL 33176, but it shall have the power and authority to establish branch offices at any other place or places as the Members may designate.

**ARTICLE VII
MEMBERSHIP RESTRICTIONS**

Additional Members may be admitted to the Company in strict accordance with the Operating Agreement of the Company. Contributions required of new Members shall be determined as of their time of admission to the Company in accordance with the Operating Agreement of the Company. A Member's interest in the Company shall be considered personal property, notwithstanding the actual nature of the assets owned by the Company and may not be sold or otherwise transferred except in strict accordance with the Operating Agreement of the Company.


**ARTICLE VIII


