**ARTICLES OF ORGANIZATION

The undersigned, Michael Smith, a natural person competent to contract and an authorized representative of Serene Shores IV, LLC, hereby presents these Articles of Organization as the Articles of Organization of Serene Shores, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**
