ARTICLES OF ORGANIZATION FOR DAHDOUH PROPERTIES, LLC

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, acting as the organizer of DAHDOUH PROPERTIES, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, <u>Fla. Stat.</u>, adopts the following Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is DAHDOUH PROPERTIES, LLC.

ARTICLE II INITIAL PRINCIPAL OFFICE
