**ARTICLES OF ORGANIZATION  
FOR

**A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, acting as the organizer of DAHDOUH PROPERTIES, LLC, under the Florida Revised Limited Liability Company Act, Chapter 605, Fla. Stat. adopts the following Articles of Organization:

**ARTICLE I
