# ARTICLES OF ORGANIZATION OF ANTHONY HOLDEN MD, PLLC

The undersigned, Anthony Holden, MD, a natural person competent to contract and member of ANTHONY HOLDEN MD, PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 605, Florida Statutes.

#### **ARTICLE I - NAME**

The name of the professional limited liability company is ANTHONY HOLDEN MD, PLLC. This professional limited liability company is referred to in these Articles of Organization as the "Company."

# **ARTICLE II - PRINCIPAL OFFICE ADDRESS**
