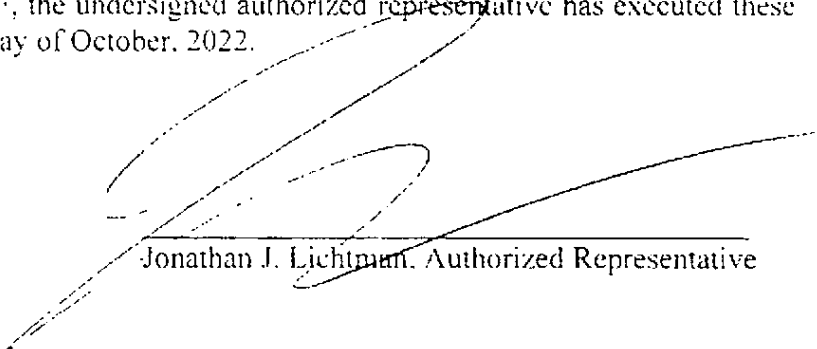
The Company is to be managed by its Managers. The persons who will serve as Sole Manager until the first annual meeting of Members or until his successor is elected and qualified is:
