**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
JIDUSH LLC**

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **JIDUSH LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:
