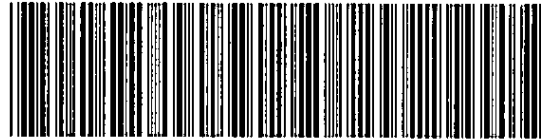




ARTICLE VIII
