ARTICLES OF ORGANIZATION OF LEO@CARTERSVILLE, LLC

The undersigned, for the purpose of forming a limited liability company under the Floriga Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

ARTICLE I NAME

The name of the limited liability company is Leo@Cartersville, LLC (the "Company").

ARTICLE II MAILING AND STREET ADDRESS
