Rigdon, a natural person competent to contract and an authorized representative of MH CHARLESTON LLC, hereby presents these Articles of Organization as the Articles of Organization of MH CHARLESTON LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

ARTICLE VI - MANAGEMENT




