In accordance with s. 605.1045, F.S., enclosed please find the Articles of Conversion, Articles of Organization, and required fees to convert an existing Connecticut LLC into a Florida Limited Liability Company.

The conversion is allowed according to the statutes of both Florida and Connecticut:

(1) The relevant Florida Statute allowing conversion of a foreign LLC to a domestic LLC is s. 605.1045: Conversion is permitted if it is done in accordance with the laws of the jurisdiction of formation (Connecticut).

(2) Section 34-631 of the Connecticut General Statutes reads as follows:

(b) Except as otherwise provided in this section, by complying with this part, a domestic entity may become a domestic entity of the same type in a foreign jurisdiction, provided the domestication is authorized by the law of the foreign jurisdiction.”


