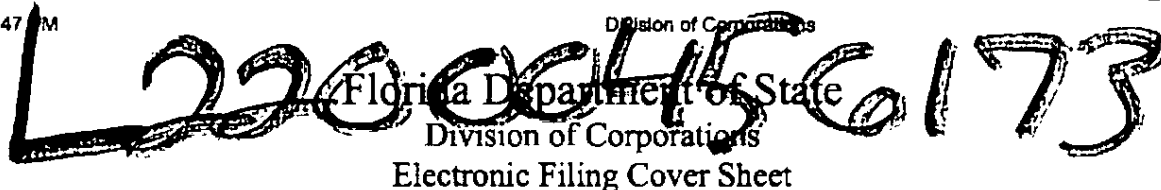

**ARTICLE II -- PRINCIPAL OFFICE AND MAILING ADDRESS**




