**ARTICLES OF ORGANIZATION**  
**OF**  
**SCALISI HOLDINGS, LLC**  
**A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a limited liability company under the Law of Florida, Chapter 605 of the Florida Statutes, and as hereafter amended, hereby certifies:

**ARTICLE I – NAME**

The name of the limited liability Company shall be SCALISI HOLDINGS, LLC.

**ARTICLE II – PRINCIPAL OFFICE**

The place in Florida where the principal office of the limited liability Company is to be located is 112 Euphrates Circle, Palm Beach Gardens, Florida 33410, located within Palm Beach County.

**ARTICLE III – PURPOSE**

The limited liability Company is organized and shall be operated exclusively for any and all lawful business purposes.


