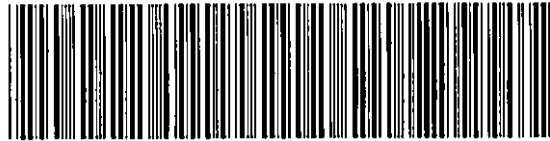

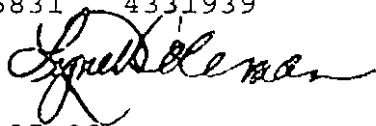

The name of the Limited Liability Company is "**KEY Group Operations, LLC**" (the "**Company**").

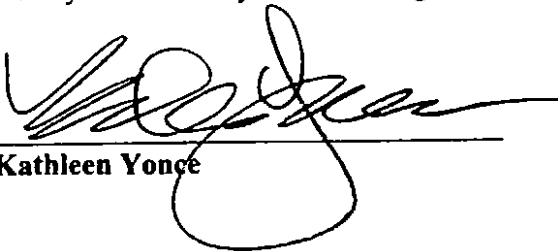
