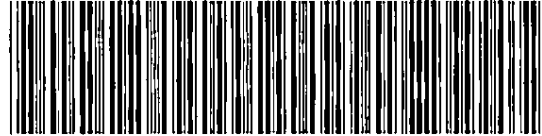

**ARTICLES OF ORGANIZATION  
FOR  
TRAFFIC MANAGEMENT SOLUTIONS, LLC**

*(A Florida Limited Liability Company)*

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (the "Act") hereby adopts the following Articles of Organization.

**ARTICLE I -- NAME**
