MANAGEMENT**

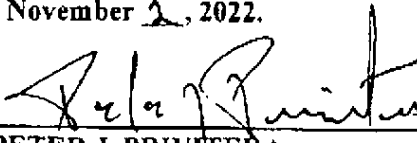

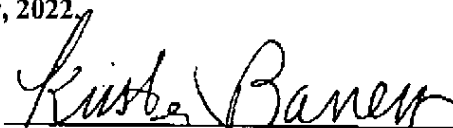
