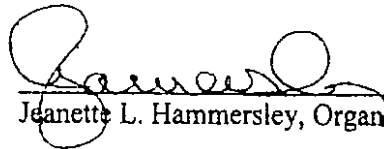

MANAGEMENT

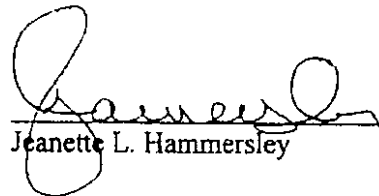
