FIRST AMENDMENT AND ADDENDUM TO THE LIMITED LIABILITY COMPANY OPERATING AGREEMENT OF SEA CLEAR POOL AND SPA LLC

We, the members of Sea Clear Pool and Spa LLC, hereby resolve and confirm that this FIRST AMENDMENT AND ADDENDUM TO THE LIMITED LIABILITY COMPANY OPERATING AGREEMENT OF SEA CLEAR POOL AND SPA LLC, effective October 15, 2023 ("Amendment"), amends and adds to the Florida limited liability company's operating agreement, initially entered into on November 7, 2022 and including any and all amendments and additions thereto executed prior to this Amendment (collectively the "Operating Agreement").

1.AMENDMENTS AND ADDITIONS. The changes and additional terms to the Operating Agreement are as follows:

- a. All references to member names, their capital contribution, and their company interest and ownership in the Operating Agreement are amended according to the "Amended Membership Composition, Capital Contributions, And Units" attached hereto. All new members understand and agree to be bound by all terms and provisions of the Operating Agreement of Sea Clear Pool and Spa LLC and all amendments and additions thereof. All new members accept the terms and conditions of their admission agreement, if one exists.
- b. All references to previous manager names in the Operating Agreement are deleted and replaced with the following manager names. The persons listed below are the exclusive managers of Sea Clear Pool and Spa LLC as of October 15, 2023.
 - i. Junius Courtney Lewis III
 - ii. Austin Elizabeth Lewis
- c. "Article II" of the Operating Agreement is amended to read as follows:

- f. "Article IV" also includes a new provision added to the Operating Agreement and reads as follows:
 - 1. ADDITIONS. The additional terms to the operating agreement are as follows:
 - a. The company will be managed solely by managers Junius C. Lewis III and Austin E. Lewis.
 - b. Junius C. Lewis III retains an ownership percentage of 51%. Austin E. Lewis retains an ownership percentage of 49%.
 - c. Upon the death or incapacitation of Junius C. Lewis III, his ownership percentage of 51% will immediately transfer to Austin E. Lewis.
 - d. Upon the death or incapacitation of Austin E. Lewis, her ownership percentage of 49% will immediately transfer to Junius C. Lewis III.
 - e. In the event that Junius C. Lewis III and Austin E. Lewis both die or both become incapacitated, Dianne S. Lewis will receive an ownership percentage of 30% and will be deemed Manager, Charlize T. Lewis will receive an ownership percentage of 50% and will be deemed Authorized Member, and Talynn N. Ryman will receive an ownership percentage of 20% and will be deemed Authorized Member.
 - f. All other provisions of the operating agreement will remain in effect, and all the foregoing amendments and additions are incorporated in the operating agreement.
- g. All other provisions of the Operating Agreement will remain in effect, and all the foregoing amendments and additions are incorporated in the Operating Agreement.

- 2. ENTIRE AGREEMENT. Each party expressly acknowledges and agrees that it has not made and is not relying on any warranties, representations, promises, or statements, except to the extent that they are expressly set forth in the Operating Agreement or this Amendment. It is understood and agreed that all understandings and agreements of the parties are merged into the Operating Agreement, as modified by this Amendment, which alone fully and completely expresses the parties' agreement.
- 3. INCONSISTENT TERMS. Any terms in the Operating Agreement that are inconsistent or conflict with the terms of this Amendment will be null and void, with the terms of this Amendment controlling and prevailing in all instances.
- 4. SEVERABILITY. If any provision of this Amendment or the application thereof is held to be invalid or unenforceable for any reason and to any extent, that provision will be considered removed from this Amendment; however, the remaining provisions will continue to be valid and enforceable according to the intentions of the parties and to the maximum extent permitted by law. If it is held that any provision of this Amendment is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision will be deemed to be written, construed, and enforced as so limited.
- 5. COUNTERPARTS; ELECTRONIC SIGNATURE. This Amendment may be executed in counterparts, including by facsimile, email, or other electronic delivery, each an original but all considered part of one Amendment.
