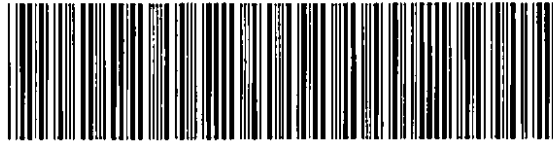

THIRD: The mailing and street address of the principal office of the Limited Liability Company is 1219 Eastin Ave, Orlando, FL 32804.




