**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
AMERICAN CYCLING GROUP, LLC**

WHEREAS, the name of the company is AMERICAN CYCLING GROUP, LLC, a Florida limited liability company ("Company"); and

WHEREAS, the Company was formed pursuant to the laws of the State of Florida on November 14, 2022 and assigned document number L22000482019; and

WHEREAS, the Incorporator of the Company has recommended the amendments to the Articles of Organization set forth below; and

WHEREAS, the undersigned Company, by and through its Incorporator and pursuant to the provisions of Section 605.0202 of the Florida Statutes, agreed to amend the aforesaid Articles of Organization in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Article IV of the Articles of Organization titled Management is deleted and restated as follows:

**ARTICLE IV
MANAGEMENT**

The Company shall be managed by the Manager(s) of the Company as provided in the Company's Operating Agreement. The initial Manager of the Company is Pablo A. Santa Cruz, at the Company's address, who shall serve until replaced according to the provisions of the Company's Operating Agreement. An authorized member of the Company is Michael Hernandez, at the Company's address.

2. The date of the foregoing amendment's adoption was November 17, 2022.
3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
