**ARTICLES OF ORGANIZATION  
OF

The undersigned hereby executes these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

**ARTICLE I**

**Name**

The name of this limited liability company (the "Company") shall be:

**ARTICLE II**

**Principal Office and Mailing Address**

The address of the principal office and mailing address of the Company shall be:

**ARTICLE III**

**Registered Office and Registered Agent**

The initial registered office of the Company shall be located at 3411 West Lykes Avenue, Tampa, Florida 33609, and the initial registered agent of the Company at such office shall be Douglas J. Dieck. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

**ARTICLE IV**

**Manager**

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
