- 1. On August 24, 2022, I, along with Messrs. Preston Abshire and Justin Dudley, filed Articles of Incorporation for "Southwest Electrical Associates Corp" with the Florida Division of Corporations. This filing was accepted effective August 29, 2022, and the company was assigned document number P22000066891.
- 2. On October 25, 2022, I, along with Messrs. Preston Abshire and Justin Dudley, filed Articles of Dissolution with the Florida Division of Corporations to voluntarily dissolve "Southwest Electrical Associates Corp." The reason for such voluntary dissolution was to enable us to refile as a limited liability company, our preferred business entity
- 3. On November 9, 2022. I, along with Preston Abshire and Justin Dudley, filed Articles of Organization for "Southwest Electrical Associates, LLC" with the Florida Division of Corporations. The filing (document number W22000142289) was received and assigned tracking number 000397455420. However, such filing was not accepted because "Southwest Electrical Associates, LLC" is the same as, or is not distinguishable from, the name of a voluntarily dissolved business entity, i.e., "Southwest Electrical Associates Corp." which we had voluntarily dissolved in order to retile as a limited liability company.

In this regard, I hereby submit this affidavit, in order to confirm that we have no intention of revoking the dissolution of "Southwest Electrical Associates Corp" and, therefore, we release the name for use as "Southwest Electrical Associates, LLC."
