**ARTICLE I**

**Name**

**ARTICLE III**

**Registered Office and Registered Agent**

The initial registered office of the Company shall be located at 1408 N. Westshore Boulevard, Suite 801, Tampa, Florida 33607, and the initial registered agent of the Company at such office shall be Brooke E. Evans. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

## ARTICLE IV

### Initial Manager

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. ### Operating Agreement

The Operating Agreement of the Company shall be for the governance of the Company and may contain any provisions or requirements for the management or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles of Organization or contrary to the laws of the State of Florida or of the United States.

## ARTICLE VI

### Amendment of Articles of Organization

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
