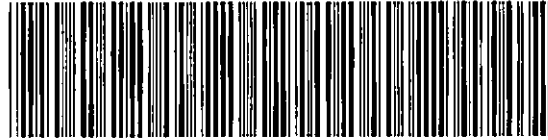

THIRD: The mailing and street address of the principal office of the Limited Liability Company is 4780 Warrior Lane, Kissimmee, FL 34746.


