# ARTICLES OF ORGANIZATION OF REAL VET LAKEWOOD RANCH, LLC

The undersigned, acting as the organizer of REAL VET LAKEWOOD RANCH, LLC under the Florida Revised Limited Liability Company Act, Chapter 605. Florida Statutes, adopts the following Articles of Organization:

#### ARTICLE I - NAME:
