**ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME

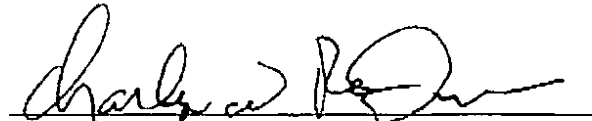
ARTICLE VI - MANAGEMENT

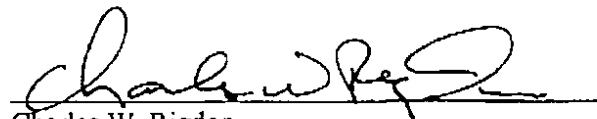
