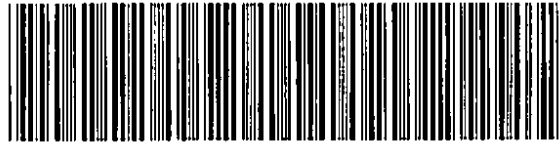

The name of the Limited Liability Company is "**SO V 335 THIRD, LLC**" (the "**Company**").


