**AMENDED AND RESTATED ARTICLES OF ORGANIZATION

Pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, the undersigned authorized representative of the Member, hereby adopts the following amended and restated articles of organization (the "Amended and Restated Articles of Organization") of Losterwood Trading, LLC, a limited liability company duly organized and existing under the laws of the State of Florida, as filed on November 16, 2022, and assigned document number L22000490786, and confirms that these Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:

The purpose of the Company is to engage in any activity or business permitted under the laws of the United States and the State of Florida including activities within the United States and abroad.


ARTICLE VII. OPERATING AGREEMENT
